Business Equipment

Business owners who acquire equipment usually prefer to deduct the cost in a single tax year, rather than a little at a time over a number of years. This deduction is known by its section in the tax code, a Section 179 deduction.

Under section 179, businesses that spend less than \$530,000 a year on qualified equipment, may write-off up to \$134,000 in 2010. The rules are designed for small companies, so the \$134,000 deduction starts to phase out when a business purchases more than \$530,000 in one year. (Companies cannot write off more than their taxable income).

Cash, Lease or Finance

Whether you pay cash, lease or finance your order, you can still take advantage of Section 179 by expensing up to \$134,000 if the equipment is put in use in 2010. Presently, however congress has this accelerated depreciation program set to expire on December 31, 2010.

Example: Assume you finance equipment, put in use in 2010, and take advantage of Section 179.

Your tax savings would be significant:



Cost of Equipment:	\$15,000.00
Section 179 Reduction if Purchases are \$530,000 + (Dollar for dollar phase out if over \$530,000)	-
Section 179 Write-Off Amount	\$15,000.00
Regular First Year Depreciation Deduction	-
Total First Year Deduction	\$15,000.00
Cash Savings on Your Equipment Purchase: (Assuming a 35% tax bracket, depreciation 5 years)	\$5250.00
Lowered Cost of Equipment after Tax Savings:	\$9750.00
